
# Northampton Country Club Recognized as Jemsek National Course of the Year

Like many of these stories, it starts with a third owner, although there have certainly been more than that.

Northampton Country Club, nestled in the Western

Massachusetts village of Leeds along the Mill River, is 125 years old, first welcoming golfers in 1898 when Leeds was the textile part of Northampton. It was a mill club, one of thousands that dotted the American landscape in the late 19th and much of the 20th centuries. Towns developed




around industry – textiles, steel, automobiles, even paper mills – and executives created recreational facilities for themselves and the citizenry. Mill softball teams made national news throughout the 1950s and 60s, and every town of 2,000 or more had a YMCA... READ MORE >>
